Welcome and thank you for selecting Aquatic Escapes Dive Center for your scuba training!

Diver training courses are meant to be fun, but like any form of learning, you will need to invest some time and effort in reading and studying. This Learning Agreement is between you (the student) and our instructional staff. It defines our mutual responsibilities in this program.

STUDENT RESPONSIBILITIES:

The student agrees to study independently as specified by the instructor. In general, this means the student will:

- Complete the online portion of your class and contact us to schedule your first session if you haven't already done so.
- Prior to your first session be prepared to be fitted for your assigned scuba equipment and be prepared to purchase scuba mask, snorkel, fins and boots if you haven't already done so (we offer different levels of pricing here).
- > Bring all paperwork, bathing suit, towel, mask, fins, snorkel and boots to each class.
- > Follow all course procedures as set forth by the instructor.
- > Ask any questions about any class-related material not understood or unclear (it's what we're here for).
- Arrive for all sessions on time and prepared for your class **.
- Make sure your instructor is aware of any stress or frustration (both under water and above). It is important to us that you are comfortable and confident.
- Your positive experience and business is important to us, we would appreciate hearing your comments anytime – Mike and Sue.

** If the student arrives at class but has failed to complete the assigned work, the student fails to arrive on time, arrives impaired or if the instructor feels you aren't able to dive, it may be necessary to make up the work and continue the class at a later date. A make-up class will be scheduled between yourself and your instructor. Due to the additional scheduling time of the staff and pool, a makeup fee of \$45.00 will apply.

- > Provide a positive learning environment in which to master the course objectives.
- > Answer the student's questions to the best of their ability and assist the student through leaning challenges. If the student completes all course work as assigned, arrives for class promptly and otherwise follows directions for learning as given by the instructor(s), we will accept responsibility for reasonable learning challenges.

Course objectives must be met before any student receives his/her certification. Under certain situations, we may schedule an additional training session where the student may have additional time to master the course objectives.

GENERAL TERMS AND CONDITIONS:

- > Your paid tuition reserves your place in the above course.
- > Aquatic Escapes Dive Center's policy on any kind of drugs and alcohol is simple ZERO TOLERANCE.
- Candidates are expected to furnish their own Surface Support and Propulsion System (mask, snorkel, boots and fins). We are here to assist you to insure that your selection meets your personalized requirements for scuba diving.
- The Air Delivery System, Air Management, Inflation System and Buoyancy Control System will be provided for Open Water Pool sessions and Open Water Dives.
- There is no refund on tuition paid, however the unused balance is transferrable. Only medical refunds for remaining class time doctors' note is required.
